Go approximately one mile, and turn left at traffic light onto Medical Parkway. Bear right at the next light and enter the Acute Care Pavilion garage. The conference will be held in the Clatanoff Pavilion, in the Clatanoff Auditorium. Ask for directions to the auditorium at the Information Desk.

From Washington, DC: Take Route 50 East to Parole exit (Exit 23). Turn right onto West Street then right onto Jennifer Road. 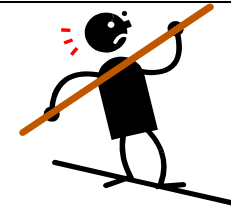
